# 4. Word from the technical director


Mark Berghaan submit his project for the last time as he won't be technical director after this GA:



We the members of ENF agree to the following:


1. When a citizen of a country of an ENF affiliated federation joins regular Naginata training in another country the local federation will report this to the federation of the country of origin.

# 5. Events in 2022 and 2023

ENC 2022 organize in Brussels with a seminar

ENC should be organize in 2023 because WNC is postpone to 2024.

Italy is candidate for 2023 for seminar and ENC will confirm by end of September 2022

David D'hose suggest to separate ENC and seminar with grading and have these each year. This proposal hasn't been approved can be studied.

# 6. ENC proposal in 2024

As WNC 2023 is postpone to 2024 we shall advance ENC to 2023 and Italy is candidate to organize it. If the WNC is organize in 2024 there will not be ENC in 2024.

# 7. ENF representative in INF

The president and the Technical director suggest that we review these two topics of the statutes:

"14.1. Directors are elected for a renewable term of four (4) years during the year of the INF Naginata World Championship"

→ Change proposal: 14.1. Directors are elected for a renewable term of four (4) years

"Article 15. INF DIRECTORS

The ENF president will fulfill the role of European Zone Director(s) to the INF Board of Directors as provided for in the Constitution & By-Laws of the International Naginata Federation."

→ Change proposal: "Article 15. INF DIRECTORS

The most qualified person in the eyes of the ENF members will represent them for the European zone in the INF meeting. This position will be reviewed at each re-election of the INF Board."

### 8. INF News

INF have decided to meet regularly online. The World Championship has been postpone to 2024 because of the Covid crisis in Japan and the problem that USNF have to booked a room for the championship.
