2. Treasurer report

The Treasurer presented the federation finances for 2022 and for 2023 up until the present day (see below). There was no report from the auditor in time for the ENF GA, so the financial report could not be confirmed at this time but needs to be confirmed at next ENF GA. Audit wasn't performed before this assembly so the report will still need to be confirmed after this presentation

There was a question raised about PayPal. Some country still wants to pay with PayPal because bank transfer is too expensive. The Vice President said he will talk with them.

The Treasurer explained the risks and problems with cash payments. The only country that is allowed to pay in cash is IRNA as they can't do bank transfer for the moment.



During the talk about the budget the ENF GA agreed to give the Technical committee an assignment to write a procedure on how member countries can propose ENF events. The ENF GA wishes to have an extra GA (online) about this in 6 months.

- ENF seminar 2024 will be organized in the Netherlands in the end of October or beginning of November.
- ENC and ENF seminar 2025 will be organized in Sweden in the end of October or beginning of November. There will most likely be a Youth Tournament at this event.
- ENF events 2026 will be decided on a coming ENF GA.

7. Shinpan seminar

The ENF GA decided to take the decision about a yearly shinpan seminar at the same time as the Technical committee proposes procedures for ENF events on the next online GA in 6 months.

The Treasurer Eduardo Brito informed the ENF GA about his resignation from his post. He leaves his post for personal reason and he will leave as soon as there is an elected replacement. The next opportunity for elections will be on the online ENF GA in 6 months.
